Site Logistics:

- 6) Bidder's attention is brought to the fact that the area of work is in the fully occupied and busy academic campus. Extensive coordination with the Facilities will be required. Contractor is expected to cooperate fully with the Facilities.
- 7) There might be some restrictions on the work activities that generate excessive noise during the mid-terms and finals. Please consult the CCNY Academic Calendar available on CCNY website for more information. DASNY will NOT compensate contractors for any additional costs associated with such modifications. Please plan accordingly.
- 8) Bidder's attention is brought to the fact that the level of noise and dust must be kept to a minimum. Dust mitigation measures must be implemented during the demolition work and throughout the course of the project.
- 9) Working Hours: Regular hours are 7 am to 3:30 pm. Contractors will be allowed to work off hours with proper notifications, permits, and supervision being provided.
- 10) Contractor will be required to submit a Certified Payroll records for all trade labor used in the construction process, such as electrician, carpenter, laborer, etc. AV integration is not usually classified as a trade work and will not be subjected to the Certified Payroll requirement
- 11) Site Specific Requirements:
 - No personal parking on site.
 - Building and ground conditions. Maintain site in the clean and professional order, debris removal on daily basis, demolition debris pile up will not be allowed.
