May an eligible community center target only one population (i.e. youth OR older adults)?	It is anticipated that the RFA, once completed would look for proposals serving the public and not limit one particular age group over another. Please be sure to respond to the questions in the RFI as the responses we receive will be used to develop future funding opportunities.
Can renovations include a community center's indoor pool, locker rooms and additional bathrooms?	In general, renovations could include any portion of the facility, either interior or exterior. Please be sure to respond to the questions in the RFI as the responses we receive will be used to develop future funding opportunities.
Can a tenant submit an RFP for renovations or must it come from the community center's landlord?	In general, tenants are permitted to request funding for an eligible project within their leased space. If the proposed project encompasses an entire building, (i.e. new roof), and the community center only leases a portion of the building, then the landlord would generally be the more appropriate one to make the grant request.
Will there be stipulations to the sale or transfer of a center property if grant funds are awarded?	In general, when capital funds are utilized to improve a facility, the recipient of the grant funds is required to maintain site control over the facility for the anticipated useful life of the improved asset. Failure to do so could be considered a default of the contract to receive funding and the recipient could be asked to repay the grant funds.
Can projects include both a renovation and expansion of community center to increase capacity?	In general a capital grant can be used for both renovation and expansion. Please be sure to respond to the questions in the RFI as the responses we receive will be used to develop future funding opportunities.
